2.2 General Licensing Rules

Oracle FLEXCUBE Universal Banking has 14 modules that can be licensed by either account metric or by application user metric. The table below lists out the modules which are primarily retail or corporate. The licensing rule against each of them defines how these modules would get licensed based on the usage of the bank.
