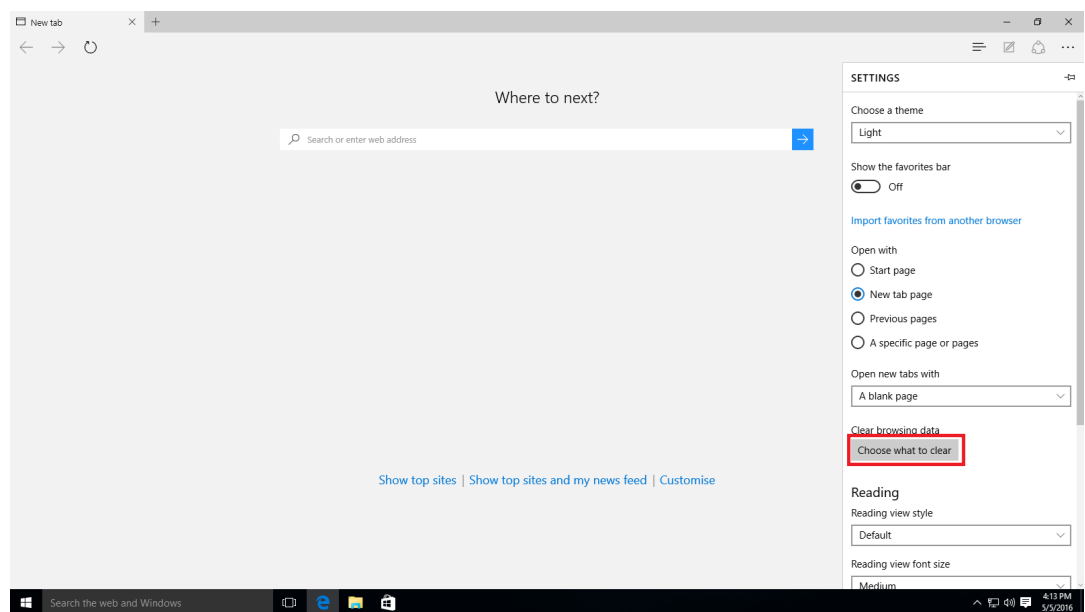

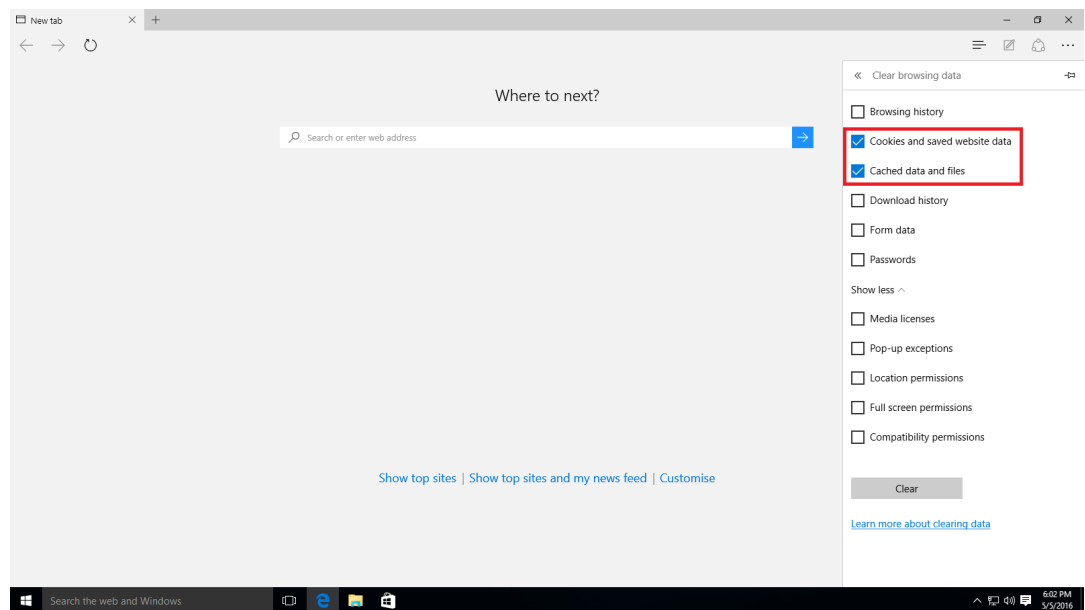
### 2.1 Clearing Cache

To clear cache, follow the steps given below:

1. Open EDGE, then Settings and click **Choose what to clear**.



2. Check the highlighted options and press clear.



## 2.2 Launching the URL

While launching the URL specify /LoginServlet along with the URL provided. If the URL already has /LoginServlet, then no need to specify.

E.g.: the URL specified should be in the format

<ip address>:<port>/<application context>/LoginServlet
