Save & Close	Click Save & Close to save the details provided and holds the task in 'My Task' queue for further update. This option will not submit the request.
Next	Click Next , system validates if all the mandatory fields have been captured. Necessary error and override messages to be displayed. On successful validation, system moves the task to the next data segment.
Submit	Click Submit to complete the transaction after you specify all the input parameters for a particular process. The task will get moved to next logical stage of the process. If mandatory fields have not been captured, system will display an error message until the mandatory fields data are provided.

Welcome to the Oracle Banking Trade Finance Process Management (OBTFPM) User Guide. This guide provides an overview on the OBTFPM application and takes you through the various steps involved in creating and processing Trade Finance transactions.

This document will take you through following activities in OBTFPM:

- To create and handle Trade Finance transaction.
- Help users to conveniently create and process Trade Finance transaction

Overview

OBTFPM is a Trade Finance middle office platform, which enables bank to streamline the Trade Finance operations. OBTFPM enables the customers to send request for new Trade Finance transaction either by visiting the branch (offline channels) or through SWIFT/Trade Portal/other external systems (online channels).

Benefits

OBTFPM helps banks to manage Trade Finance operations across the globe in different currencies. OBTFPM allows you to:

- Handle all Trade Finance transactions in a single platform.
- Provides support for limit verification and limit earmarking.
- Provide amount block support for customer account.
- Provides acknowledgement to customers.
- Enables the user to upload related documents during transaction.
- Enables to Integrate with back end applications for tracking limits, creating limit earmarks, amount blocks, checking KYC, AML and Sanction checks status.
- Create, track and close exceptions for the above checks.
- Enables to use customer specific templates for fast and easy processing of trade transactions that reoccur periodically.

- Stand-alone system that can be paired with any back end application.
- Minimum changes required to integrate with bank's existing core systems.
- Faster time to market.
- Capable to interface with corporate ERP and SWIFT to Corporate.

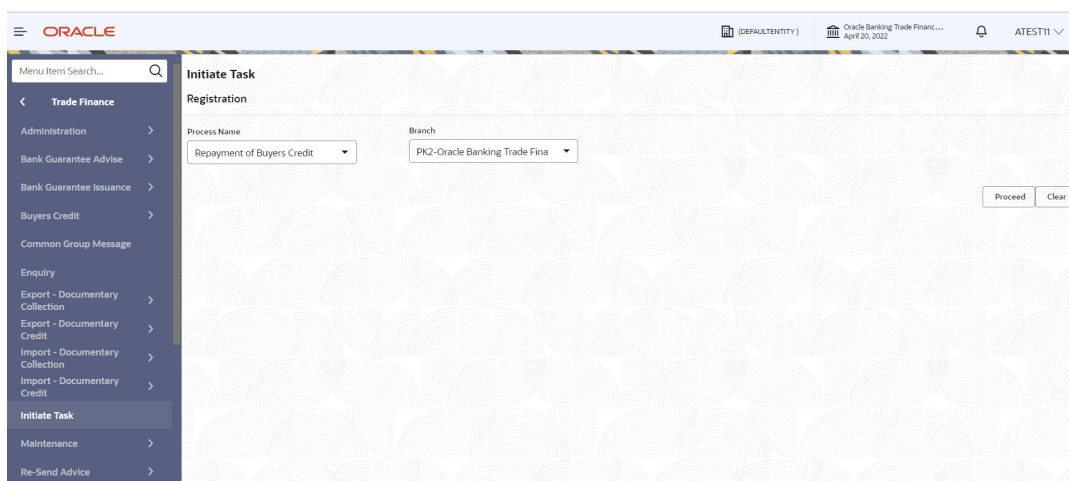
2.1 Common Initiation Stage

Specify **User ID** and **Password**, and login to **Home** screen.

1. On **Home** screen, click **Trade Finance**. Under **Trade Finance**, click **Initiate Task**.

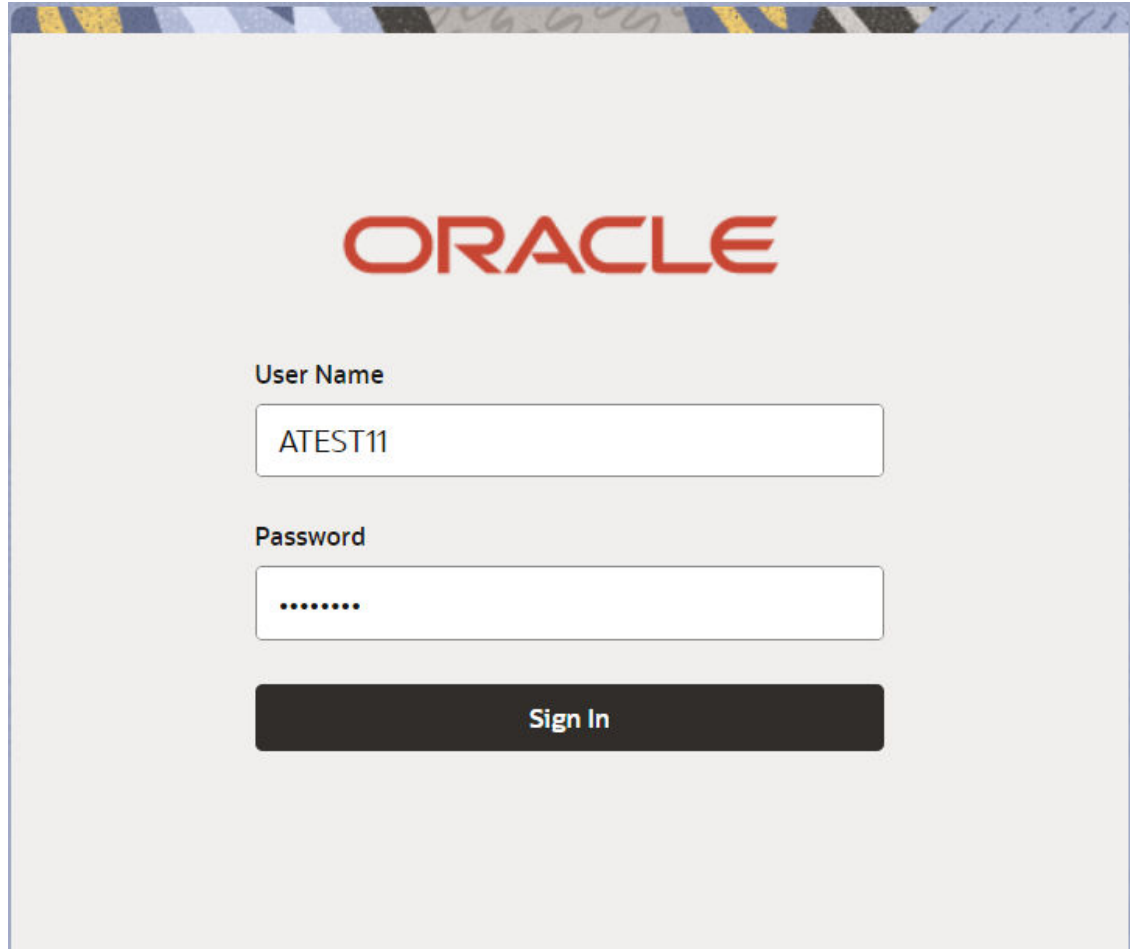
2.2 Registration

This topic provides the systematic instructions to initiate the Registration stage of Repayment of Buyers Credit request.

The process starts from Registration stage, during Registration stage, user can capture the Bill under Letter of Undertaking for Buyers Credit and upload the related documents. On submit of the request, the customer will be notified with an acknowledgment and the request will be available for an expert to handle the request in the next stage.

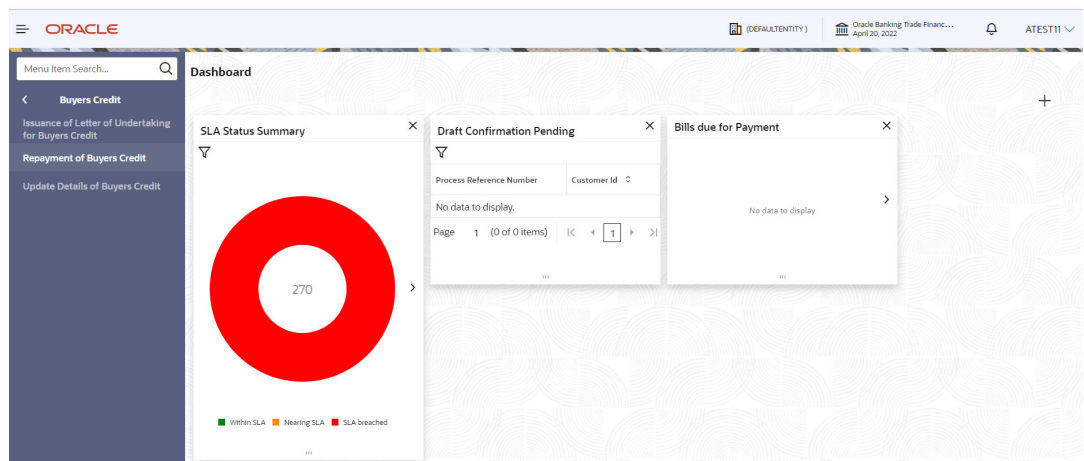
Specify **User ID** and **Password**, and login to **Home** screen.

Priority	Priority is defaulted from the application as Low/Medium/High/Essential/Critical. User can change the priority populated any time before submit of Registration stage.

Submission Mode	Submission mode is auto-populated. By default the submission mode will have the value as 'Desk'. <ul style="list-style-type: none"> • Courier - Request received through Courier • Desk - Request received through Desk • Fax - Request received through Fax • Email - Request received through Email The user can modify the submission mode if required.
Branch Date	Read only field. By default, the application will display branch's current date
Process Reference Number	Read only field. Unique OBTFPM task reference number for the transaction. This is auto generated by the system based on process name and branch code.

Buyers Credit Details

Registration user can provide Buyers Credit details in this section. Alternately, details can be provided by Data Enrichment user.

4. On **Registration - Buyers Credit Details** screen, specify the fields.

Field	Description
Product Code	Read only field. Product code is auto-populated.
Product Description	Read only field. This field displays the description of the product as per the selected product code.
Contract Reference Number	Read only field. Contract Reference Number will be auto populated by the system based on Product Code
Amount In Local Currency	Read only field. After the tab out of 'Currency Code, Amount' field, system populates the Local currency and amount value in this field. System fetches the local currency equivalent value for the LC amount from back office (with decimal places).
Lending Bank	Read only field. This field displays the lending bank details.
Liquidation Amount	Specify the liquidation amount in this field. Liquidation amount cannot be lesser than the Bill Amount. Currency code is auto populated.
Limit verification required	Read only field. This field displays whether limit check during the process flow of this request is required or not.
Quote Reference Number	Read only field. This field displays the Quote Reference Number, mentioned in the Buyers Credit Quotation received from the Lending Bank.
Quote Date	Read only field. This field displays the Quote Date.
Value Date for Disbursal	Read only field. This field displays the buyers credit disbursal date.
Buyers Credit Tenor	Read only field. This field displays the buyers credit tenor. The user can change the value for tenor of the bill (days, month and year).
Buyers Credit Due Date	Read only field. This field displays the buyers credit due date.
Interest Code	Read only field. This field displays the interest rate code.
Interest Spread	Read only field. This field displays the interest rate spread, mentioned in the Buyers Credit Quotation received from the Lending Bank. The user can change the value.
Interest Rate	Specify the interest rate, mentioned in the Buyers Credit Quotation received from the Lending Bank. It should be a positive numeric value.
Interest Amount	Specify the interest amount, mentioned in the Buyers Credit Quotation received from the Lending Bank. It should be a positive numeric value.

Field	Description
Import Bill Reference Number	Read only field. This field displays the Import Bill Reference Number.
Exporter Details	Read only field. This field displays the exporter details.

The following documents are to be maintained for Document Upload / Linkage, <ul style="list-style-type: none"> • Buyers Credit Request • Buyers Credit Quotation.
Remarks	Specify any additional information regarding the Repayment of Buyers Credit. This information can be viewed by other users processing the request.
Overrides	Click to view overrides, if any.
Customer Instruction	Click to view/ input the following: <ul style="list-style-type: none"> • Standard Instructions – In this section, the system will populate the details of Standard Instructions maintained for the customer. User will not be able to edit this. • Transaction Level Instructions – In this section, OBTFPM user can input any Customer Instructions received as part of transaction processing. This section will be enabled only for customer initiated transactions.
Signatures	Click the Signature button to verify the signature of the customer/ bank if required. The user can view the Customer Number and Name of the signatory, Signature image and the applicable operation instructions if any available in the back-office system. If more than one signature is available, system should display all the signatures.
Hold	The details provided will be saved and status will be on hold. User must update the remarks on the reason for holding the task. This option is used, if there are any pending information yet to be received from applicant.
Cancel	Cancel the Repayment of Buyers Credit task. Details entered will not be saved and the task will be removed.

Field	Description
Save & Close	Save the information provided and holds the task in 'My Task' queue for working later. This option will not submit the request.
Submit	Click Submit, system will trigger acknowledgment to the customer and give confirmation message for successful submission. The task will move to next logical stage of Repayment of Buyers Credit. If mandatory fields have not been captured, system will display an error message until the mandatory fields data are provided.
Checklist	Click to view the list of items that needs to be completed and acknowledge. If mandatory checklist items are not selected, system will display an error on submit.

2.3 Liquidation

This topic provides the systematic instructions to initiate the Liquidation stage of Repayment of Buyers Credit request.

As part of Liquidation, user can enter/update additional details, if any.

Under Liquidation stage, user can capture details that are not captured as part of the Registration stage or can modify the details if any captured as part of the Registration stage.



Note:

For expired line of limits, the task moves to “Limit Exception” stage under Free Tasks, on ‘Submit’ of DE Stage with the reason for exception as “Limit Expired”.

Specify **User ID** and **Password**, and login to **Home** screen.

1. On **Home** screen, click, **Task**.
2. Under **Task**, click **Free Task**.

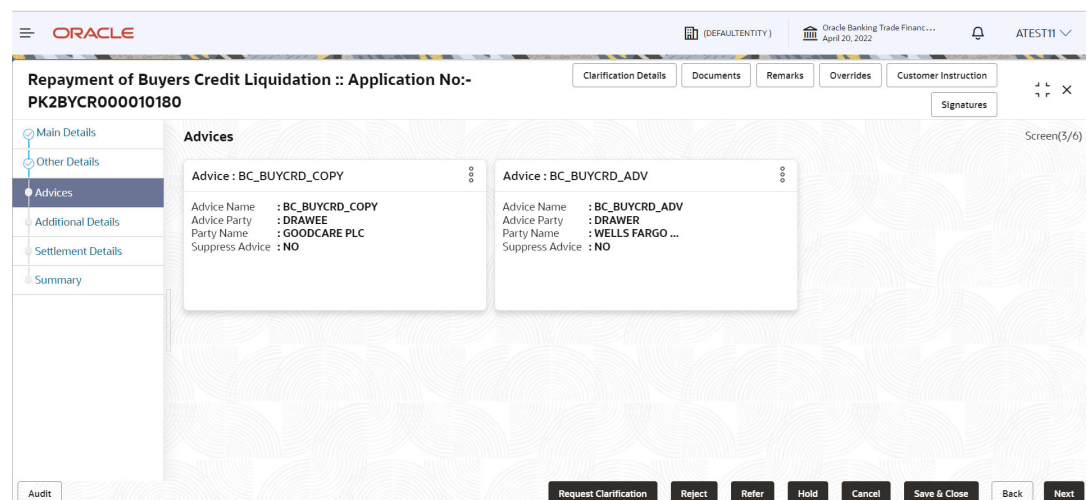

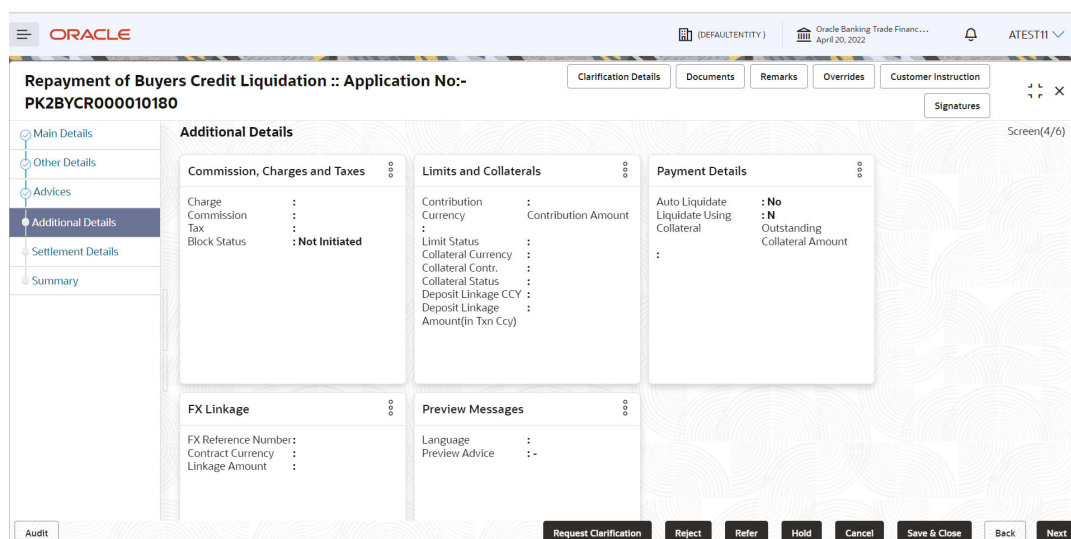

2.5 Multi Level Approval

This topic helps you quickly get acquainted with the Multi Level Approval process.

A User can view the summary of details updated in multilevel approval stage of Repayment of Buyers Credit request.

1. Log in into OBTFPM application and acquire the task available in the approval stage in free task queue. The user can view the Summary tiles which displays list of important fields with values.
2. Click each tile to drill down from summary Tiles into respective data segments to verify the details of all fields under the data segment.

Note:

The user can simulate/recalculate charge details and during calling the handoff, if handoff is failed with error the OBTFM displays the Handoff failure error during the Approval of the task.

Authorization Re-Key (Non-Online Channel)

For non-online channel, application will request approver for few critical field values as an authorization step. If the values captured match with the values available in the screen, system will allow user to open the transaction screens for further verification. If the re-key values are different from the values captured, then application will display an error message.



Open the task and re-key some of the critical field values from the request in the Re-key screen. Some of the fields below will dynamically be available for re-key.:


- Currency
- Contract Amount

Re-key is applicable to the first approver in case of multiple approvers. All approvers will however be able see the summary tiles and the details in the screen by drill down from tiles.

2.6 Handoff

This topic helps you quickly get acquainted with the Handoff process.

On successful handoff of the task, System will handoff the Buyers Credit details to the back office and the Buyers credit contract will be liquidated in the back office.

System should generate the necessary accounting entries and messages in the back office.

 **Note:**

1. System should not allow the user to liquidate the Bill under Letter of Undertaking for Buyers Credit bill, when the Import Bill is not liquidated under the Linkages.
2. Partial Liquidation is not allowed and system needs to validate the same.
3. System should validate the Liquidation date with the Buyers Credit Due date and should display appropriate override for the same.
