HISTORY OF THE SOFTWARE  =====</p> <p>Python was created in the early 1990s by Guido van Rossum at Stichting Mathematisch Centrum (CWI, see <a href="http://www.cwi.nl">http://www.cwi.nl</a>) in the Netherlands as a successor of a language called ABC. Guido remains Python's principal author, although it includes many contributions from others.</p> <p>In 1995, Guido continued his work on Python at the Corporation for National Research Initiatives (CNRI, see <a href="http://www.cnri.reston.va.us">http://www.cnri.reston.va.us</a>) in Reston, Virginia where he released several versions of the software.</p> <p>In May 2000, Guido and the Python core development team moved to BeOpen.com to form the BeOpen PythonLabs team. In October of the same year, the PythonLabs team moved to Digital Creations (now Zope Corporation, see <a href="http://www.zope.com">http://www.zope.com</a>). Whether this is true is especially significant if the work can be Third Party Product Licenses and Notices 23 linked without the Library, or if the work is itself a library. The threshold for this to be true is not precisely defined by law.

If such an object file uses only numerical parameters, data structure layouts and accessors, and small macros and small inline functions (ten lines or less in length), then the use of the object file is unrestricted, regardless of whether it is legally a derivative work.
